The final number of shares to vest (0% - 150%) shall be determined based on the performance results. Unvested shares are subject to forfeit should eligible employment end.
- The option grant shall vest at a rate of 50% of the shares subject to the option on the first anniversary of the grant date, 25% on the second anniversary of the grant date and the final 25% on the third anniversary of the grant date.
