Explanation of Responses:

- Performance shares shall vest following the end of the Corporation's 2009 fiscal year (approximately 6/30/2009). Vesting requirements include continuous employment and achievement of certain performance results by the Corporation for the cumulative period from January 26, 2007 through the end of fiscal year 2009. The final number of shares to vest (0% - 150%) shall be determined based on the performance results. Unvested shares are subject to repurchase by the Corporation should the eligible employment end.
- The restricted stock award shall vest 100% of the shares subject to the award on February 28, 2010, the third anniversary of the award date, if eligible employment continues through that date. Unvested shares are subject to repurchase by the Corporation should eligible employment end.
- The option shall vest at a rate of 50% of the shares subject to the option on the first anniversary of the grant date, 25% of the second anniversary of the grant date and the final 25% on the third anniversary of the grant date.
